2.4 Eligibility Criteria

To be eligible for the Certificate Course, applicants must meet the following requirements:

Essential: A minimum qualification of Class10th pass and a minimum age of 18 years.

2.5 Medium of Instruction

The course will be delivered in a bilingual mode (Hindi and English) to ensure accessibility for a wider range of learners. A basic understanding of both languages will be beneficial for effective learning and participation.

2.7 Number of Seats and Reservation Policy

The minimum numbers of seats are 20 (Twenty). The PSSCIVE provides reservation in admission for various categories of learners, including Scheduled Castes, Scheduled Tribes, non-creamy layer of OBC, Economically Weaker Sections (as notified by MHRD through OM 12-4/019-U1 in January 2019) and Person with Disabilities in accordance with the Government of India rules for admission to the certificate course. However, any learner found to have submitted a forged certificate under any category will not only have their admission cancelled but also face legal action, as per the rules of the

Government of India. Reservation of seats: EWS-10%, OBC(NCL)-27%, SC-15%, ST-7.5% and PH-4%.
